And

The **M.C.College**, Barpeta through the **Principal, M.C.College, Deptt. of Botany as the Nodal deptt.**, Barpeta -781301, Assam of the other part.

1. PREAMBLE.

The **Daffodil College of Horticulture**, Khetri – 782403, Kmarup (Metro), Assam is a professional college affiliated to the Assam Science and Technology University, Jalukbari-781014. The College (DCH) has also been approved and recognized by the Department of Higher Education, Govt. of Assam. The **DCH** has state-of-the-art nursery and laboratory, smart and virtual classrooms, facilities for vocational trainings, accredited mother plant block, facilities which not only could support the existing academic programmes but also various research activities.

Madhab Choudhury College (M.C. College), Barpeta, the fourth oldest college in undivided Assam, was established on 14th July in the year 1939. Since then, M.C. college has

Whereas, the **DCH, Khetri** and **M.C. College, Barpeta** share a common goal to explore, extend and strengthen the functional relationship in academics and through other R & D ventures.

The **DCH, Khetri** and **Deptt. of Botany as the Nodal Deptt., M.C. College, Barpeta** in order to share the facilities & explore available resources in each other's institution herewith sign a Memorandum of Understanding (MoU).

2. PURPOSE AND OBJECTIVES

The purpose of the MoU is to create a common framework and a platform for collaboration with specific objectives as given below:

- I. To establish a close linkage and functional coordination between **DCH, Khetri** and the **Deptt. of Botany as the Nodal Deptt., M.C. College, Barpeta**;
- II. To share access to both conventional and digital library facilities;
- III. To facilitate joint projects for conduct of research, training and consultancy with industries/departments in Assam, India and abroad;
- IV. To facilitate creation/development of new experimental and research/training facilities through mutual co-operation through exchange of experts etc.;
- V. To avail accommodation of facilities like stadium (Indoor & Outdoor), auditorium, Seminar Halls, laboratories etc.;
- VI. Any type of expenditure incurred through the joint programmes held under this MoU will be borne as per mutual agreements which will be made on case to case basis. Otherwise each of the parties shall meet the expenditure from their own sources;
- VII. To set a long term institution-industry partnership by providing training, exchanging faculty and personels, conducting workshop and seminar etc.
- VIII. To provide sufficient knowledge and skill to the students of both the institutions.
- IX. To provide hands on training to the students of both the institutions for enhancement of their skills in various aspects of horticulture.
- X. To ensure technical support to the faculties and stakeholders for setting up small scale/ large scale nursery for teaching learning process.
- XI. To exchange study materials and intellectual expertise between both the institutions for skill enhancement papers of CBCS syllabus and other relevant diploma, certificate and ad hoc course etc.

- (iv) The Arbitrator proceeding shall be held at Guwahati.
- (v) The decision of the **Arbitrator** shall be final and binding upon both the parties.
